

We connect clients for wrap-around services for mental, physical, and legal assistance. We offer recovery housing for clients who need sobriety while creating pathways for their children to thrive. Clients in our program will receive support and encouragement to help them determine their own worthwhile tapping into their own creative spark and creating objects that are proof of their capacity.
