- A. Paws to People Organization
- II. Address
- A. The corporation will be headquartered at 204 Hermosa Dr NE, Albuquerque, NM 87108-1024
- III. Purpose
- A. This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. It is formed for charitable purposes
- B. IV. Powers

Notwithstanding the preceding statement of powers, this corporation shall not, except to a substantial degree, engage in any activities or powers that are not in furtherance of the primary purpose of this corporation.

V. Directors

The number of directors of this corporation shall be established by the bylaws of this corporation.

VI. Member

The number, classes, rights and identification of the members, if any, of this corporation shall be established by the bylaws of this corporation.

VII. Restrictions

- A. This organization is organized and operated exclusively for charitable and research funding purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 (or any corresponding provision of any previous or future United States Internal Revenue Law) and meeting the requirements for exemption provided by Section 7-9-29 NMSA 1978 of the New Mexico Revenue and Taxation Code. Any other provisions of these articles of incorporation notwithstanding, this corporation shall not carry on any activities not permitted to be carried on (i) by a corporation exempt from Federal income Tax under Section 501(c)(3) of the Internal Revenue Code or (ii.) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.
- B. No part of the net earnings or assets of this corporation shall ever inure to the benefit of any founder, director, officer, contributor or member of this corporation or to the benefit of any private individual whatsoever (except that reasonable compensation may be paid for services

rendered to or for the corporation affecting one or more of its purposes). No substantial part of the activities of this corporation shall consist of lobbying or carrying on propaganda or otherwise attempting to influence legislation, except as provided in Section 501(h) of the Internal Revenue Code, and this corporation shall not, directly or indirectly, participate or intervene in any political campaign (including publication or distribution of statements) on behalf of or in opposition to any candidate for public office.

VIII. Dissolution or Winding Up

The assets and property of this organization is irrevocably dedicated to charitable purposes meeting the requirements for exemption provided by Section 7-9-29 NMSA 1978 of the New Mexico Revenue and Taxation Code , and no part of net income or assets of this organization shall inure to the benefit of private persons. Under the dissolution or winding up of this organization, its assets remaining after payment, or provisions for payment of all debts and liabilities of this organization shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes meeting the requirements for exemption provided by Section 7-9-29 NMSA 1978 New Mexico Revenue and Taxation Code, and which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code.
