SEVENTY-FIVE PERCENT OF THE DIRECT LABOR PERFORMED ON THESE CONTRACTS IS BY INDIVIDUALS WITH SEVERE DISABILITIES WHO COULD NOT MAINTAIN EMPLOYMENT WITHOUT LIFEROOTS SUPPORT AND TRAINING. THE FEDERAL EMPLOYMENT OPPORTUNITIES ARE PROVIDED BY THE FEDERAL SET-ASIDE PROGRAM KNOWN AS JAVITS WAGNER O'DAY (JWOD). ABILITYONE FORMALLY KNOWN AS THE NATIONAL INSTITUTE FOR THE SEVERELY HANDICAPPED (NISH) ASSISTS THE ORGANIZATION IN CONTRACTING MATTERS USING THE JWOD PROGRAM. CONTRACTS WITH THE STATE OF NEW MEXICO ARE PROVIDED USING THE STATE-USE PROGRAM.
