WE CONTINUED OUR COMMUNITY-CENTERED PROGRAMS AND COMMITMENT TO PROTECTING WATER RIGHTS AND REVITALIZING AGRICULTURE IN OUR COMMUNITIES, AND WE ALSO ADAPTED TO BUILD NEW PROGRAMMING AROUND DISASTER RECOVERY AND CLIMATE RESILIENCY.
