Question and Answer:

Q: Has organization or any of its officers, directors, employees or fund raisers ever been enjoined or otherwise prohibited by a government agency/court from soliciting?

A: No The organization's license has not been revoked, suspended or denied by any state, but simply lapsed due to nonrenewal. The organization is working to submit all renewals in such states it will solicit contributions.

A: No The organization's license has not been revoked, suspended or denied by any state, but simply lapsed due to nonrenewal. The organization is working to submit all renewals in such states it will solicit contributions.

Q: *Has organization or any of its officers, directors, employees or fund raisers ever been the subject of a proceeding regarding any solicitation or registration?*

A: Yes The Black Lives Matter Global Network Foundation did not become aware of the Indiana civil investigative demand (“CID”) until April 22, 2022, when the Indiana Attorney General’s office sent an e-mail notice to the BLMGNF attorney of record. The e-mail did not include a copy of the CID. On April 25, 2022, just one business day later and before BLMGNF could obtain a copy and respond, the Indiana Attorney General filed suit against BLMGNF in Indiana state court to compel a response to the CID. BLMGNF did not receive a copy of the CID earlier due to an administrative issue with a registered agent. The Foundation is now in receipt of the CID and is working with its counsel to address the matter immediately. Marian County, Indiana Circuit/Superior Court; 49D01-2204-MI-013657; Verified Petition to Enforce Civil Investigative Demand; 4/26/22.
