Charity Purpose: Our Mission is to help homeless, near-homeless, and low-income women achieve stable, self-supporting lives for themselves and their families. Most of our clients are survivors of traumatic circumstances including rape victims, human trafficking, incarceration, or homelessness. We have developed a 12-month training curriculum and will assist them with employment after the completion of our program. Our goal is to help them break the cycle of homelessness and empower them for a better future.

In 2019, we partnered with Metropolitan Detention Center (MDC) and added Recover Housing to our programs in 2020 in order to assist released inmate and provide housing for them if the need be while giving them tools to help them achieve their goals and live self-sufficient lives outside jail. In 2023, we added transitional housing to our program to benefit homeless women and their children under the age of fifteen.
